Vitis vinifera for effective and sustainable plant disease control

OPSeed75 contains at least 75% polyphenols and provides control of crop fungi such as downy mildew and apple scab. Thanks to its proven fungicidal effect, it can be used on authorized crops, including grapevine (*Plasmopara viticola*), apple trees (*Venturia inaequalis*), potatoes (*Phytophthora infestans*), and lettuce (*Peronospora* sp. and *Bremia lactucae*).

Compatible with other plant protection products, OPSeed75 can be used combined for optimal effectiveness.

"We developed OPSeed75 from grape seeds controlling the supply chain so that we ensure the quality and high polyphenol rate of this extract," explains Laurent CUBIZOLLES, R&D and Regulatory Affairs Director for finished products.
